

# Solair Recreational League Waiver and Release Agreement Issued 3-20-2026

This document affects your legal rights. Please read carefully before signing.

## 1 Assumption of Risk

Camping and recreational activities involve inherent and other risks that may result in serious bodily injury, illness, death, or property damage. I voluntarily and intentionally assume all risks, known and unknown. I assume and accept responsibility following all ground rules and posted signs and for conducting myself in a safe manner.

## 2 Responsibility for Minors

If there are minors in my care, I assume all risks on their behalf and accept full responsibility for their supervision and safety. I certify I am the parent or legal guardian. I consent to their participation in all activities.

## 3 Examples of Activities and Risks

**General activities, sports & events:** risks include slips, trips, falls, equipment failures, water-related injuries, illness.

**Swimming pool, pond, waterfronts: no lifeguards on duty.** Obey all posted signs. Minors must be accompanied by an adult per rules. Minors under age 13 must wear a personally owned, fitted life jacket when in or on watercraft.

**Hot tub:** Obey posted signs; confirm your medical fitness. Improper use creates higher risk of injury or drowning.

**Fitness Center:** Unattended; meant for adults familiar with equipment. Work with a partner to reduce risk of injury.

**Hiking:** Trails are rough with potential hazards like cliffs, wildlife, and insects. Limited or no cell coverage.

**Riding bikes, trikes, etc:** Expect unpaved, hilly terrain. Helmets required for minors under 16, recommended for all.

**Campfires-:** Never leave campfires unattended; keep them within reach of a working water hose. Fire Risk.

## 4 General Acknowledgement

I understand not all risks are foreseeable. I am responsible for my safety. I must read and follow the Ground Rules posted on the website and obey all posted signs. I understand that noncompliance may result in my removal from the property without a refund and/or denial of future entry.

## 5 Medical Authorization

In the event of injury or emergency, I authorize Solair to obtain emergency medical treatment for me or any minor under my supervision. I understand I am responsible for all related medical expenses.

## 6 Release of Liability

To the fullest extent permitted under the laws of the State of Connecticut, I hereby knowingly and intentionally waive, release, indemnify and hold harmless **Solair**, its owners, officers, managers, employees, agents, contractors and volunteers (**Released Parties**) of all liability for accidents, injuries, damages or losses arising from my presence on property or participation in activities, including claims arising from the ordinary negligence of the released parties.

## 7 Indemnification

I agree to defend, indemnify, and hold harmless the Released Parties against all claims, liabilities, damages, losses, judgments, costs, or expenses (including reasonable attorney's fees) arising from my actions, the actions of my guests, and/or the actions of any minor child under my supervision.

This agreement shall be governed by and interpreted in accordance with the laws of the State of Connecticut.
